- Furthermore, I grant Ontario Play & Café the right to record me, my spouse, my parents, any accompanying adult and any of the children below on the installed video surveillance system.
- I agree that if any portion of this agreement is found to be void or unenforceable, the remaining portions shall remain in full force and effect.
